William Temple House is seeking a visionary and strategic **Director of Development** to lead our growing development team and advance a mission that serves Portland's most underserved communities. This is a high-impact role for an experienced and inspiring fundraising leader with a strong background in major gifts, donor engagement, and collaborative strategy development.



As Development Director, you will be responsible for designing and executing a unified fundraising strategy that generates \$1 million annually in support of core operations. You will cultivate deep, lasting relationships with donors and galvanize internal stakeholders—including the Executive Director, Board of Directors, and the Marketing Manager—around the feasibility and execution of ambitious development goals.

You will lead new fundraising initiatives such as endowment growth, planned giving, and special campaigns, all while tracking metrics to ensure accountability, sustainability, and continued mission impact.
